## MIXING DIRECTIONS

Mix well before use. Liquid Formulations: **Phyta-Guard® Citronella** should be added to the spray water after all other pesticide and nutrients are added and dissolved. **Use Phyta-Guard® Phyta-Oil as an adjuvant.**

## DIRECTIONS FOR USE

**Pesticides: Phyta-Guard® Citronella** is used to control and repel various aphid and scale insects.

**Dormant Orchard Sprays:** (100-500 gallons per acre) Use one to three pints per acre. For the control of red scale.

**Citrus Sprays:** (100-500 gallons per acre) Use one to three pints per acre. For the control of red scale, aphid, mealybug, and thrip.

**Lettuce, Cole Crops, Spinach, Beets, Radishes and other vegetables:** Use one to three pints per acre. Use for the control of aphid. *DO NOT APPLY AT COTYLEDON STAGE (Two Leaf).*

**Squash, Melons, Cucumbers:** Use one to three pints per acre. Use for the control of aphid. *DO NOT APPLY AT COTYLEDON STAGE (Two Leaf).*

**Tomatoes:** Use one to three pints per acre. Use for the control of aphid.

**Potatoes:** Use one to three pints per acre. Use for the control of aphid.

**Beans:** Use one to three pints per acre. Use for the control of aphid.

**Cotton:** Use one to three pints per acre. Use for the control of aphid.

**Wheat:** Use one to three pints per acre. Use for the control of aphid.

**Grapes:** Use one to three pints per acre. Use for the control of aphid.

**Peaches, Plums, Nectarines, Apricots, Walnuts, Pistachios, Almonds, Pecans:** Use one to three pints per acre. Use for the control of aphid.
