MIXING DIRECTIONS

Mix well before use. Liquid Formulations: **Phyta-Guard® Concentrate Liquid** should be added to the spray water after all other pesticide and nutrients are added and dissolved. **Use Phyta-Guard® Phyta-Oil as an adjuvant for best results.**

DIRECTIONS FOR USE

Pesticides: Phyta-Guard® Concentrate Liquid is used to repel various aphid and scale insects.

Dormant Orchard Sprays: (100-500 gallons per acre) Use 2 to 6 ounces per acre to repel red scale.

Citrus Sprays: (100-500 gallons per acre) Use 2 to 6 ounces per acre to repel scale, aphid, mealybug, thrip and other insects.

Lettuce, Cole Crops, Spinach, Beets, Radishes and other vegetables: Use 2 to 6 ounces per acre at a maximum concentration of 3%. Use to repel aphid. **DO NOT APPLY AT COTYLEDON STAGE (Two Leaf).**

Squash, Melons, Cucumbers: Use 2 to 6 ounces per acre. Use to repel aphid. **DO NOT APPLY AT COTYLEDON STAGE (Two Leaf).**

Tomatoes: Use 2 to 6 ounces per acre. Use to repel aphid and other insects.

Potatoes: Use 2 to 6 ounces per acre. Use to repel aphid and other insects.

Beans: Use 2 to 6 ounces per acre. Use to repel aphid and other insects.

Cotton: Use 2 to 6 ounces per acre. Use to repel aphid and other insects.

Wheat: Use 2 to 6 ounces per acre. Use to repel aphid and other insects.

Grapes: Use 2 to 4 ounces per acre. Use to repel aphid and other insects.

Peaches, Plums, Nectarines, Apricots, Walnuts, Pistachios, Almonds, Pecans: Use 2 to 4 ounces per acre. Use to repel aphid.
