### MIXING DIRECTIONS

Mix well before use.

**Liquid Formulations:** **Phyta-Oil™** should be added to the spray water after all other pesticide and nutrients are added and dissolved.

### DIRECTIONS FOR USE

**Pesticide:** **Phyta-Oil™** controls various aphid and scale insects.

**Dormant Orchard Sprays:** (100-500 gallons per acre) Use 2-4% of the total amount of water. For the control of red scale.

**Citrus Sprays:** (100-500 gallons per acre) Use 1% of the total amount of water. For the control of red scale, aphid, mealybug, and thrip.

**Lettuce, Cole Crops, Spinach, Beets, Radishes and other vegetables:** Use 1/2 to 2 gallons per acre at a maximum concentration of 3%. Use for the control of aphid. **DO NOT APPLY AT COTYLEDON STAGE (Two Leaf).**

**Squash, Melons, Cucumbers:** Use 1/2 to 2 gallons per acre at a maximum concentration of 3%. Use for the control of aphid. **DO NOT APPLY AT COTYLEDON STAGE (Two Leaf).**

**Tomatoes:** Use 1/2 to 2 gallons per acre at a maximum concentration of 3%. Use for the control of aphid.

**Potatoes:** Use 1 to 2 gallons per acre at a maximum concentration of 5%. Use for the control of aphid.

**Beans:** Use 1 to 2 gallons per acre at a maximum concentration of 5%. Use for the control of aphid.

**Cotton:** Use 1 to 2 gallons per acre at a maximum concentration of 5%. Use for the control of aphid.

**Wheat:** Use 1 to 2 gallons per acre at a maximum concentration of 5%. Use for the control of aphid.

**Grapes:** Use 1 to 2 gallons per acre at a maximum concentration of 5%. Use for the control of aphid.

**Peaches, Plums, Nectarines, Apricots, Walnuts, Pistachios, Almonds, Pecans:** Use 1 to 2 gallons per acre at a maximum concentration of 5%. Use for the control of aphid.
